

## **Calvary Chapel Freiburg<sup>1</sup> Anti-Infection Protection Policy**

**(Effective from Monday, January 25, 2021; person responsible for compliance: Alexander Gasnik & the main-usher during the service)**

1. Registration in advance is mandatory in order to attend a service: <https://ticket.ccfreiburg.de/>
2. The valid distancing regulations (at least 1.5 m.) must be adhered to.
3. The maximum number of attendees is 55 in the sanctuary downstairs and 55 in the gallery.
4. All attendees must check-in and disinfect their hands when entering the building for CCF events.
5. The external and internal doors on the right side of the building will function as the entrance, and the external and internal doors on the left side of the building will function as the exit, both for entering and leaving the building and also for moving through the building during services. Please follow the arrows!
6. Attendees will be shown to their places by the ushers. Places will be allocated from the third row from the front, and places will be filled from the front to the back and from the centre outwards to the side aisles. Between attendees (either individuals, or couples of the same household) a gap of three seats must be maintained.
7. Only every second row of seats may be occupied, the one in between must remain free.
8. Children up to two years of age may be brought to the service but must sit on their parents' lap.
9. For the gallery, the same seating rules shall apply: three seats between attendees [individuals/couples of the same household], only every second row may be occupied, crosses mark the seating spots in the rear area. Children up to two years of age must sit on their parents' lap.
10. Face masks: It is mandatory for all attendees to wear face masks all the time and everywhere in the building. It is also mandatory to wear a medical mask or a FFP2 mask.<sup>2</sup> For children between the age of 6 and 14 years an everyday mask must be worn. Attendees that are freed from masks should provide a medical certificate. We would encourage those attendees to wear visors instead.
11. Disinfection is mandatory for all attendees each time the sanctuary or gallery is re-entered. After using the washroom, washing hands with soap is mandatory. The distancing measures for and in front of the washrooms, indicated by lines on the floor must be followed. After using the washrooms, disinfection is still mandatory upon re-entering the sanctuary or gallery.
12. The washrooms behind and below the stage may only be used by volunteers, the worship band and leaders in exceptional circumstances.
13. If, in addition to the reserved places for registered attendees, there are still places available (without exceeding the maximum number of attendees), attendees not having registered in advance may be admitted, however they must register (by providing name and contact information) before entering the building. We kindly ask all attendees to co-operate with the ushers.
14. After a service, the sanctuary should be vacated promptly. Vacation shall begin with the back row furthest from the stage followed by each row closer towards the stage. In accordance with current state government regulations, we encourage fellowship after the service to take place outside the building.

15. Extensive disinfection measures must be carried out before and after each event: toilets, taps/faucets, handrails, door handles and door panels, tables and other surfaces, armrests of the chairs.
16. Supplementary regulations can be found on the hygiene concepts posted on the entrance and exit doors in the main sanctuary.
